Dear Shareholder:

As announced on February 28, 2020 the Community Capital Management Alternative Income Fund (the "Fund") paid a distribution of \$0.79000 per share to each shareholder of record as of February 27, 2020.

The following table sets forth the estimated amounts of the current distribution paid and the cumulative distributions paid this fiscal year to date from the following sources: net investment income and return of capital. All amounts are expressed per common share.

The amount of distributable income for each fiscal period depends on the dividend and interest income received as well as the aggregate capital gains and losses realized by the Fund during the entire year. The Fund pays a dividend out of the distributions that are received from its underlying investment holdings, some of which are not considered income or capital gains. Certain distributions received by the Fund from real estate investment trusts (REITs) may consist of dividend income, return of capital and capital gains, and the character of these distributions cannot be determined until after the end of the Fund's fiscal year, which is May 31st. The distribution may also include distributions from master limited partnerships (MLPs), in which the character of income or return of capital cannot be determined until the K-1s are received. In addition, other common stocks can pay a dividend in which part of the amount is considered a return of capital.

The amounts and sources of the distribution reported above are only estimates on a book basis. These estimates may, and likely will, vary over time based on the investment activities of the Fund and changes in the value of portfolio investments. The sources of the distribution may later be determined to be from taxable net investment income, short-term gains, long-term gains, and/or return of capital.

The actual amounts and sources of the distribution amounts for tax reporting purposes may be subject to change based on tax regulations. The Fund will send you a Form 1099-DIV for the calendar year that will detail these distributions for federal income tax purposes.
